INTRODUCTION

Setting big game controlled hunt tag numbers and developing regulations for the following year's big game seasons involves two major steps.

1. The 2012 big game controlled hunt tag numbers are adopted as Oregon Administrative Rules by the Oregon Fish and Wildlife Commission (Commission) on June 7–8, 2012 in Salem, Oregon.
2. Recommendations, in concept, are presented for 2013 big game and western gray squirrel season dates, bag limits, and open areas, dates and locations of cooperative travel management areas, and controlled hunts. Final adoption of 2013 Big Game Regulations will occur at the October 5, 2012, Commission meeting in Salem, Oregon.

This document includes tables of controlled hunts with Oregon Department of Fish and Wildlife (Department) recommended tag numbers proposed for adoption in June 2012 and a summary of 2013 Big Game Regulation proposals. It should be noted, the 2013 Big Game Regulations are concepts at this time, subject to revision and further development.

GENERAL TOPICS and UPDATES

Potential Regulation Changes and Concepts Under Consideration

Several miscellaneous regulation concepts and proposals were mentioned in the information provided to the Department's wildlife districts for discussion at public meetings held in May (Table 1). If proposals are developed they would be presented at the October 5, 2012, Commission meeting for potential inclusion in the 2013 Big Game Regulations.

Bag Limit During Archery Seasons and for Hunters with Disabilities Permits

Following are some factors considered to determine which Wildlife Management Units (WMUs) are recommended to have an expanded bag limit to include antlerless animals:

- The deer or elk population characteristics in the unit particularly:
 - Population level relative to the population Management Objective (MO)
 - Recruitment as measured by fawn or calf ratios
- The number of antlerless firearms tags authorized in the unit
- The distribution of firearms tags in the unit

In June of 2012, the Department will make projections on which units will have an antlerless animal in the bag limit for archers and hunters with disabilities permits for fall of 2013. If the Commission adopts this proposal in October 2012, the Department would list the units with an expanded bag limit in the 2013 Big Game Regulations.

- Elk bag limit changes in the Ritter portion of the Heppner WMU, the Catherine Creek WMU, and the Chesnimnus WMU. The Department proposal is to add these three areas to the group of units that include an antlerless animal in the bag limit for archery hunters and hunters with an Oregon Disabilities Hunting and Fishing Permit.
 - The Ritter area is predominantly private land with other antlerless hunts focused on damage caused by elk.
 - The Catherine Creek and Chesnimnus WMUs elk populations are estimated to be above their MO. The elk population in the Catherine Creek WMU is estimated at 1,050 (MO, 700); the Chesnimnus WMU population is estimated at 5,300 (MO 3,500).

Antlerless tags for rifle hunts are also proposed to increase, with a focus on areas where much of the land is private. There is some concern regarding antlerless harvest on public lands where elk numbers are not as high.

There is some risk, which the Department believes is manageable, in setting antlerless areas a year ahead of seasons. If an extreme winter was to occur causing a major reduction in deer and/or elk herds in areas with antlerless animals in the bag limit, the Department would propose an emergency rule change by April 15th (same reporting deadline as for canceled hunts) to protect antlerless animals in the impacted areas.

West Cascades and Ochoco WMU Antlerless Elk Hunts

The Department is considering proposals that would severely reduce antlerless elk hunting on USFS lands on the west slope of the Cascades for almost all hunters; muzzleloader, rifle, archery, and those with Disability Permits. The concept is to have a bag limit of “One Bull Elk” on National Forest lands. Elk numbers and calf ratios have declined in many areas of the west Cascades. It is not a bull ratio issue; reducing bull hunting would have little effect on the elk population decline on USFS lands. Exceptions could include a low number of youth hunts and areas along the fringe of the forest where damage is occurring.

There is a similar concern for the elk population on USFS lands in the Ochoco WMU. An option being considered is to issue two types of Ochoco Unit Archery Elk tags.

1. Unit-wide archery tags for "One Bull Elk"
2. Unit-wide archery tags for "One Elk"
 - a. The intent is to maintain the total number of archery tags but reduce antlerless harvest on USFS lands.

Travel Management Area (TMA) and Area Closure Changes

White River Wildlife Area

The Department is proposing to change current area OAR's for the White River Wildlife Area related to camping and motor vehicle use. Current off-road vehicle use has risen to the point of being detrimental to the Wildlife Area, and new campsites are being continually developed. The issue has been compounded by recent changes in OHV rules on adjacent Forest Service lands. Proposed rule changes would allow camping only in designated areas, and prohibit ATV/OHV use on the wildlife area except by permit or for administrative use.

Columbia Basin WMU Archery Closure Boundary Change

The Columbia Basin Archery closure has been in place since 1985, and was initiated by a group of the affected landowners. Several landowners in the current closure area have asked to have the bowhunting closure lifted. On January 30, 2012, the Heppner District sent a letter to all of the landowners (121) in the archery closure area requesting their input as to whether the closure should be kept or dropped (a meeting date was set for mid-February). A total of nine phone calls were received between the Heppner and Pendleton offices. Seven of the calls requested keeping the closure and two requested dropping the closure.

Four people attended the February meeting and all of them wanted to have the closure dropped. The initial landowners who contacted the Heppner District to remove the archery restriction, all of the people at the meeting, as well as the two phone calls who wanted the closure dropped live within the area proposed to be open. Only two of the seven phone calls requesting the closure be left in place live within the area proposed for opening. The District contacted both of these landowners after the meeting and relayed the potential proposal to open a portion of the current closure area. Both landowners said that they would rather see it closed, but if other people wanted it open they would not oppose the new proposed boundary.

Current Boundary:

Columbia Basin Unit is closed to all bowhunting beginning at Heppner, north and west on State Hwy 74 to Lexington, north and east on State Hwy 207 to Butter Cr Junction, south on Butter Creek Rd to Hwy 74 at Vinson, west on Hwy 74 Heppner.

New Proposed Boundary:

Columbia Basin Unit is closed to all bowhunting beginning at Vinson at the intersection of Hwy 74 and Butter Creek Road, west on Hwy 74 to Sandhollow Rd, north on Sandhollow Rd to Baseline Rd, west ½ mile to Sandhollow Rd, north on Sandhollow Rd to Hwy 207, north and east on State Hwy 207 to Butter Creek Junction, south on Butter Creek Rd to Hwy 74 at Vinson. The proposed change would reduce the closure are by 85 mi² (27%), from 313 to 228 mi².

Tags for Active Duty Military Personnel

This concept was introduced by a member of the public. Time off can be difficult for persons in the military to plan and is prone to change. The idea is to provide a mechanism for Oregon's active duty service members stationed out of state to obtain a controlled deer or elk hunt tag if they are in Oregon during the season so they can hunt with their family and friends.

The idea is to provide a block of deer/elk tags (10?) to each District that can be sold over the counter.

- Tags could be sold for most hunts except for "premier" hunts, such as hunts with bucks or bulls in the bag limit and require quite a few points to draw, such as;
 - MT Emily, Walla Walla, or Wenaha "one bull" tags
 - Late season mule deer hunts
 - Juniper Muzzleloader
- Tags would be good for Commission adopted hunts (dates, bag limit, etc.)

Many details remain to be developed, such as determining requirements to participate and how to document eligibility.

Black-tailed Deer Management Plan

The Oregon Black-tailed Deer Management Plan was adopted by the Oregon Fish and Wildlife Commission in November 2008. In 2011, using the Mule Deer Initiative process as a guideline, four western Oregon WMU's (Chetco, Indigo, Tioga and Trask) were selected as emphasis units to concentrate efforts to identify limiting factors and find solutions designed to increase black-tailed deer populations. For each of these units working groups made up of representatives of sporting groups, public and private land managers, local government agencies, conservation groups and hunters have begun meeting to develop action plans to address unit specific problems. These action plans, when completed, will then be presented in a Black-tailed Deer Management Plan Implementation document.

A primary objective in the plan is to develop improved population estimates for black-tailed deer. Tooth collection efforts have continued with tooth envelopes for submitting teeth being made available at all license agents and Department offices. During 2011, as in previous years, the Department mailed envelopes to hunters with controlled hunt tags for black-tailed deer and attempted to inform general season black-tailed deer hunters with information in the regulations and with multiple press releases. However, resulting tooth return rates from hunters remain low; 1,932 teeth were returned from 2011 seasons. Both the number of teeth and return rate (10%) are very similar to 2010 numbers. The current rate of return is not sufficient to develop a good population model.

The Department is also working on an inventory method which has recently been developed and is being utilized in Alaska. This is an updated fecal pellet transect count utilizing DNA obtained from the mucus on the exterior of the fecal pellet to identify individual deer. This information will then be used in a mark-recapture analysis to determine population levels and density estimates. In conjunction with the new fecal pellet DNA collection method, a deer collaring project has been started in the Indigo and Trask WMUs and two comparison units (Dixon and Alesa) to gain knowledge on deer home range size, habitat selection, and mortality factors. Expansion of collaring to additional WMUs will depend on funding and available personnel.

Activities continue to be implemented relative to other objectives in the black-tailed deer plan (e.g. working with land managers regarding habitat management for black-tailed deer), in the remainder of wildlife management units as opportunities arise.

Mandatory Reporting of Hunter Harvest and Effort

The mandatory hunter reporting system has been operational for four full years. Overall, for the first full year of reporting (2008-09 seasons) hunters reported on 15% of the tags issued (Table 2). The reporting rate more than doubled to 36% for 2009-10 seasons. However, by the end of March 2011 there was no apparent increase in reporting for the 2010 seasons. The Department subsequently mailed a reminder postcard to 147,000 hunters with outstanding reportable tags and an additional 54,000 reports were received, for a cost of \$38,000. Reporting rates for the 2011–2012 seasons dropped to 41%. Hunter compliance continues to be too low to provide reliable information.

Hunters can report either by telephone or through the Department’s web site. Although both telephone and internet are functional, feedback from hunters indicates it is far easier to successfully complete surveys on the internet. The Department is working with the contractor to make the phone system more user-friendly and dependable. Hunters can access the hunting

report form through the Hunter Resource section of the web site, <http://www.dfw.state.or.us/resources/hunting/reporting/index.asp>, or call 1-866-947-ODFW (6339) for the automated phone system. Hunters who purchased bighorn sheep and Rocky Mountain goat tags do not have to report as these hunters are required to check out of the hunt area.

As an incentive for hunters to report on time, hunters that report on their hunts by a specific date are entered into a drawing for special tags similar to Auction and Raffle tags (long season, statewide, etc.). The drawing will occur in June 2012 for three special tags. Hunters drawn have their choice of a deer, elk, or pronghorn tag. Reporting deadlines for the special tag drawing were:

- January 31, 2012 for hunts that ended on or before December 31, 2011.
- April 15, 2012 for hunts that ended between January 1-March 31, 2012.
- June 30, 2011 for Spring Bear and Turkey seasons, all of which ended May 31, 2011.

Additionally, hunters who do not report by the specified deadlines for tags offered in the 2012 Regulations may not be able to purchase a license without paying a penalty. The penalty is planned to be assessed beginning December 2013 with purchase of a 2014 license because many 2013 licenses would be purchased before reporting deadlines. The penalty fee amount, up to \$25, will be established in October 2012. Initially the penalty will be implemented for not reporting on deer and elk tags. Deer and elk general seasons have some of the lowest compliance rates and the information is critical and time sensitive for setting seasons and controlled hunt tag numbers. The penalty fee in other states range from \$10 to \$50.

All hunters are encouraged to complete a worksheet found online and in the Big Game Regulations to help prepare for the survey. The worksheet is general; there are additional questions for some hunts. Before calling the phone line or logging into the online system, hunters should have the following information ready:

- Hunter/Angler ID number (located on ODFW licenses, tags and applications)
- The two-digit WMU number of the unit hunted. If the hunt area included more than one WMU, use the number of the unit hunted in most of the time.
- The total number of days hunted—including mentoring youth
- The number of days hunted in the WMU hunted most

With all hunters reporting, and providing accurate information, the new system will improve the quality and quantity of hunting effort and harvest information. For additional information, visit the Department's web site, www.dfw.state.or.us

2011–2012 Emergency Hunt Summary

The Department relies heavily on district-approved emergency hunts to solve severe animal damage situations. District emergency hunts are implemented on the recommendation of the local biologist with authorization from the Regional Manager or Watershed Manager. This process allows the local biologist to respond to severe damage situations quickly and effectively. Districts are allocated 250 emergency hunt tags per county. Once the allotment of tags is exhausted, biologists must request a Director-Approved Emergency Hunt.

During 2011-2012, 10 district emergency hunts were authorized, 6 for elk, 2 for pronghorn and 2 for turkey (Table 3). As a result, 32 hunters harvested 5 elk, 0 pronghorn and 4 turkeys. Compared with 2010–2011, the number of emergency hunts decreased 23 percent, participating hunters decreased 74 percent, elk harvest decreased 93 percent, no change in pronghorn harvest and turkey harvest decreased 20 percent.

Landowner Preference Program

Since its inception in 1981, the Landowner Preference (LOP) program has been liberalized to allow property owners more flexibility. Tag exchanges continue to be very popular and effective for participating landowners. Exchanges continue to work well for addressing some hard-to-solve deer and elk damage situations by providing landowners more options to utilize harvest as a damage management tool.

The 2003 Oregon Legislative Assembly adopted a bill that directed the Commission to implement a LOP pilot project for antlerless elk in southwest Oregon. The SW Oregon Pilot Project was authorized to occur on private lands in Jackson, Josephine, Coos, Curry, and Douglas counties between July 1, 2004 and June 30, 2008. The 2007 Legislature extended the Pilot Project through June 30, 2014. The project is intended to demonstrate the Department's commitment to solving damage by:

- allowing the landowner to personally select damage hunt participants,
- increasing public access to elk through LOP tags and redistribution of animals,
- reducing or eliminating some damage hunts,
- being less time consuming for landowners to participate.

The rules provide LOP tags to landowners where elk are currently causing damage, where there has been a history of damage coupled with actions to alleviate elk damage, or where elk are located in an "elk de-emphasis zone".

Following is a summary of LOP tag exchanges and LOP damage tags issued during 2011–2012 (Table 4). The summary and the table are comprised of three parts, the "standard" LOP program for the entire state, the Southwest Oregon Pilot Project which is for elk only, and combined Grand Totals.

Under the statewide LOP program, not including SW Oregon:

- 1,069 LOP tags were exchanged for 1,856 damage tags; 130 for deer, 938 for elk.
 - 282 tags were exchanged "1 for 1" and 787 exchanged "1 for 2".
- 85 controlled hunt tags were exchanged "1 for 1"; 10 for deer, 75 for elk.

In the SW Oregon Pilot Project in categories not authorized for the statewide LOP program:

- 604 additional elk tags were issued in SW Oregon
 - 259 new tags
 - 28 LOP 1:1 tags
 - 214 unused general season tags
 - 103 unused controlled tags

Statewide Grand Totals:

- 2,545 LOP tags were issued for damage, a 4 percent increase from 2010–2011.
- A total of 1,247 animals were harvested
 - 149 deer, a 9 percent decrease from 2010–2011.
 - 1,098 elk, a 1 percent increase from 2010–2011.

Guide and Outfitter Tag Sales

The Guide and Outfitter (G&O) Tag Allocation program was initiated by statute in 1997. The program allocates 50 percent of the previous year’s total non-resident tags drawn for controlled deer and elk to Guides and Outfitters who may sell deer tags for \$497.25 and elk tags for \$733.75, a higher fee than the normal non-resident price. The initial tag purchase deadline is March 31 and remaining tags are sold on a first-come, first-served basis from April 1- April 15. Up to five tags per G&O may be purchased without naming clients, and tag fees are nonrefundable. Outfitter tags not sold by April 15 of each year are returned to the normal controlled hunt drawing in June.

In 2012, 37% of available deer tags were drawn and 26% of those drawn were sold (Table 5). Forty percent of available elk tags were drawn and 36% of those drawn were sold. Three deer tags and 27 elk tags were purchased as leftovers, without named clients.

First-Come, First-Served Tag Sales Update

Controlled tags leftover after the drawing are sold on a first-come, first-served basis. Tags sold in this manner are in addition to tags drawn normally. Last year (2011), 139 deer tags in 1 hunt and 636 elk tags in 11 hunts were sold in this manner; most tags sold in a matter of minutes. For 2012 Spring Bear hunts, 172 tags in 4 hunts were sold in the first-come, first-served process.

Disability Hunting Permits

The new criteria for Disabilities Permits adopted by the 1999 Legislative Assembly were implemented in 2000. Enrollment in the Disabilities Permit program subsequently increased from about 600 in 1999 to peak at approximately 20,000 in 2006-07. The number of individuals

qualifying for this permit declined during the transition to the “Oregon Disabilities Hunting and Fishing Permit” which requires participants to renew permits every two years.

Tag holders with Disabilities Permits are surveyed separately from the main telephone harvest survey to estimate harvest (Table 6). Between 2000 and 2004 antlerless harvest increased along with the number of hunters with Disabilities Permits. Following changes to bag limits for hunters with Disabilities Permits in 2005, number of tags sold, harvest, and percentage of antlerless animals in the harvest have declined for deer and elk.

Wildlife Health

The issue of wildlife health is playing an ever-increasing role in all Department programs and continues to add complexity and challenge to management of Oregon’s wildlife resources. Disease continues to impact wildlife populations and game management strategies. When disease has caused population declines, the Department has responded with management efforts like reducing antlerless deer tags and harvest pressure to insure long-term population health and persistence.

The Department’s wildlife veterinarians have taken the lead in developing and implementing protocols for monitoring the health of Oregon’s wildlife and surveillance for diseases including Deer Hair Loss Syndrome (DHLS) and Adenovirus Hemorrhagic Disease in deer, bacterial pneumonia in bighorn sheep, and Chronic Wasting Disease (CWD). The Department’s monitoring and surveillance efforts must be vigilant and effective for tracking, detecting and responding to the presence of any disease in Oregon’s wildlife.

Hair Loss Syndrome in Deer

DHLS is a condition affecting both black-tailed and Columbian white-tailed deer. DHLS is caused by heavy infestations of exotic lice. The condition produces hair discoloration, hair loss,

weight loss, diarrhea, lethargy and can result in death from exposure and associated pneumonia. Trends in DHLS for western Oregon deer are static.

Recently, field staff have identified and confirmed that a different exotic louse is causing symptoms in eastern Oregon mule deer. Field staff will continue sampling to determine the extent and prevalence in mule deer populations.

Chronic Wasting Disease in Wild Deer and Elk

Chronic Wasting Disease (CWD) is a disease of the nervous system known as a transmissible spongiform encephalopathy (TSE) affecting the deer family. CWD is of considerable interest throughout the United States due to the impacts to deer and elk populations and fiscal resources tied to monitoring, surveillance, and eradication efforts. CWD has not been detected in any Oregon samples obtained since testing began in 1996. Samples are collected and analyzed annually to determine whether CWD is present or absent in wild populations. Testing is conducted primarily from hunter harvested deer and elk. Since 2002, Department field staff has sampled over 13,000 deer and elk for CWD. Information from field checks indicates hunters continue to be concerned about the disease and are cooperative when asked to allow sample collection.

There is currently a parts and carcass import ban in the states or provinces with a documented case of CWD including Alberta, Colorado, Illinois, Kansas, Maryland, Michigan, Minnesota, Missouri, Montana, Nebraska, New Mexico, New York, North Dakota, Oklahoma, South Dakota, Wisconsin, Wyoming, Utah, Virginia, West Virginia, and Saskatchewan. The Department shall add by temporary rule any additional states or provinces when any new cases of CWD arise.

HUNTING SEASONS and SPECIES SPECIFIC INFORMATION

Proposed Controlled Hunt Tag Numbers

Total proposed controlled tags for the 2012–2013 seasons are changing very little (-1%, Table 7). Total proposed controlled deer tags are down slightly (-1%), and proposed controlled pronghorn tags are up slightly (+1%). Overall, proposed controlled elk tags are changing less than 1%. Proposed bighorn tags are up 4 tags (+4%) whereas Rocky Mountain goat tags are unchanged at 11. No changes are proposed for 2013 controlled spring bear hunts or for the limited Southwest Oregon first-come, first-served bear season.

Proposed General Season Bag Limits and Dates

The Department is proposing no changes to bag limits for the 2013 general big game seasons (Table 8). The 2013 general bear season will remain standardized and will open August 1, 2013 and close November 30 in eastern Oregon or December 31 in western Oregon. The general cougar season will open January 1, 2013 and close on December 31, 2013. Most hunts for other species will be adjusted according to the normal calendar shift.

Proposed 2013 Application and Tag Sale Deadlines

Controlled hunt application deadlines are set to occur the same date each year (Table 9). Tag sale deadlines (Table 10) are set at 11:59 pm the day before each respective season opens, except general bear and general cougar tags which have the same tag sale deadline as for buck deer. For bighorn sheep and Rocky Mtn. goats the tag sale deadline is the last day of the hunt.

Bear Season Summaries and Recommendations

Overview

Bear populations remained stable throughout Oregon with some local population increases. The total number of complaints recorded for black bear decreased 50% from 921 in 2010 to 452 in 2011. The relatively high number of complaints during 2010 was probably in part a result of poor berry production in western Oregon. The majority (67%) of complaints were related to damage by bears. Of the total number of complaints, garbage-related complaints accounted for ~27% and timber damage accounted for ~8%. The number of bears killed as a result of damage decreased 9% to 352 in 2011 compared to 2010. Most conflict-related mortality (96%) continues

to occur in western Oregon where human and bear populations are highest resulting in property damage, human safety concerns, and nuisance problems.

2011 Spring Bear Harvest

A total of 7,569 spring bear tags were sold during 2011 (down 1% from 2010). Of these, 3,698 were for controlled spring hunts and 3,999 were sold first-come, first-served for the Limited SW Oregon hunt. Telephone harvest surveys indicate 262 bears were taken during the spring controlled hunt and 226 bears were taken during the Limited SW Oregon hunt for a total of 488 spring bear taken by 4,736 hunters during 2011. The average success rate for both the Controlled Spring Bear hunters and the SW Oregon Limited hunt was about 10%. Most of the bears harvested (74 %) were males.

2011 General Bear Seasons

The number of general season black bear tags issued decreased slightly from 49,840 in 2010 to 49,379 in 2011. Telephone harvest surveys suggested 63% of tag holders hunted and took 931 bears. Most of the general season bear harvest was from western Oregon and 79% were males. Continued monitoring of harvested bear ages suggests bear populations are not being over-harvested. Age data from bears harvested during 2011 is currently incomplete because not all teeth have been processed by the contracted laboratory. Consequently,

median ages cannot be estimated at this time. In addition to assessing level of harvest based on median ages, the Department has included percent of males greater than or equal to 5 years old in the harvest and percent of females in the harvest to help ascertain harvest levels (light, moderate, high). Following these criteria, between 1989 and 2010, the harvest of black bears has not exceeded a moderate level during any year.

Because of previous low black bear tooth return rates (Table 11) the Department implemented a mandatory check-in of bear skulls in 2008 as directed by the Bear Plan. Specifically, successful hunters are required to bring the unfrozen skull of any bear they harvest to a Department office or a designated check-in site within 10 days of harvesting their bear. Biologists or trained volunteers collect a premolar tooth for aging. This information is important for monitoring population structure, and when combined with statewide tetracycline marking, for estimating black bear populations. A total of 1,329 teeth were submitted by bear hunters in 2011 (Table 11). Tooth return rates are very high again for 2011. Age data for all sampled bears should be available by mid-winter 2012–2013.

2013 General Bear Season Recommendations

The Department recommends no changes to season dates. Proposed general season dates are August 1–November 30, 2013 in eastern Oregon, and August 1–December 31, 2013 in western Oregon. The Department recommends maintaining the second general bear opportunity with the SW Additional Bear tag valid in 10 SW Oregon WMU's. The additional tag may be purchased throughout the season; however, hunters must purchase the general season tag prior to the deadline to be eligible to purchase an additional tag. For 2013, the proposed tag sales deadline is September 27, 2013. The Department will continue mailing letters to all 2013 bear tag holders in an effort to remind hunters of the requirement to check in bears.

2013 Spring Bear Season/Tag Recommendations

In October, the Department will be proposing 4,395 controlled tags in 19 hunts and 4,000 tags in the SW Oregon Limited hunt for 2013 (Table 12). The 4,000 proposed SW Oregon tags will be sold first-come, first-served beginning the same time 2013 hunting licenses become available (December 1, 2012), and will be available until March 31, 2013 or until the authorized number of tags are sold. Consistent with current practices for general deer and elk seasons, hunters who purchase these tags before the application deadline for controlled spring bear hunts cannot apply for spring bear preference points or tags for the 2013 season.

Black Bear Tetracycline Marking Study

Beginning in 2005, the Department began using tetracycline to mark bear teeth statewide. Using the ratio of marked and unmarked teeth provided by hunters and collected through other forms of mortality the bear population can eventually be estimated. As noted earlier, tooth return rates have increased with the requirement for mandatory check-in (Table 11), improving sample collection for estimating bear populations. The Department will continue to refine the estimation process and work towards providing an estimate of black bear populations with these results.

Cougar Season Summaries and Recommendations

Target Areas

Currently, four Cougar Target Areas, as described in the 2006 Cougar Management Plan (Chapter VI, Adaptive Management Process) have been implemented to address declining ungulate populations. Beginning in December 2009, through April 13, 2012, a total of 162 cougars have been administratively removed from the Steens Mtn., Ukiah, Warner, and Wenaha target areas (Table 13).

Cougar-Bear Agents

The 2007 Oregon Legislative Assembly passed House Bill 2971 authorizing the Department to develop rules necessary to appoint individuals as Department agents for cougar and/or black bear control work and research projects. Subsequently, rules were developed and approved by the Commission in February 2008.

To qualify as an agent of the Department, interested individuals must pass a criminal background check, provide a fingerprint record, provide a certified copy of their Motor Vehicles Driving Record for the past five years, and complete a Black Bear and/or Cougar Agent Application.

Qualified applicants are interviewed by the respective district wildlife biologist to determine suitability for appointment. Those selected will be required to meet with the district biologist and successfully complete required training (Code of Conduct, Use of Firearms, Use of ATVs and Snowmobiles, First Aid/CPR, etc.). Before being asked to take a control action, the agent and the district wildlife biologist will complete a Black Bear and/or Cougar Agent Appointment Agreement that establishes specific work-related duties, equipment requirements etc., for that particular project. As of February 24, 2012, 24 agents are approved and have signed agreements. One agent continues to be used to capture cougars for research in the Mt. Emily Unit, and agents are being used in the Ukiah, Warner, and Wenaha target areas and to address specific conflicts with cougars.

Population Monitoring

With increased management intensity for cougars in specified target areas, the Department has also increased intensity of monitoring efforts. The Department continues to use the improved damage complaint form and database for tracking complaints associated with conflict. Known cougar mortality information is consistently updated to insure no cougar management zone quotas are exceeded. The Department continues to develop information for hunters about how they can help, and how to collect appropriate biological samples from harvested animals. The Department has also contracted with a university to develop a contemporary stochastic population model for cougars in Oregon.

Population Overview

Population modeling suggests a 2% increase in cougar numbers for 2011 to 5,848. The total number of damage complaints received was stable with 469 in 2010 and 484 in 2011, although data for 2011 are preliminary (Table 14). Non-hunting mortalities increased 8% to 261 in 2011 (Table 14).

2011 Cougar Harvest

Cougar tag sales continued to increase, up 4% to 50,889 in 2011, but harvest remained stable at 241 (Table 14). Some hunters continue to hunt specifically for cougar outside of the deer and elk seasons when snow conditions allow animals to be tracked or by using a predator call. When the Department began using cougar harvest quotas in 1995, only animals taken during hunting seasons were counted toward quotas. Since adoption of the Cougar Management Plan in 2006, all known mortalities count toward zone quotas. Cougar Zone A (Coast-North Cascades) was closed (**bold italic text**) to hunting on December 29, 2011 based on the established quota; this zone was reopened when the next season started on January 1, 2012 (Table 15). Mortalities related to damage management were up almost 60% in 2011 (46) compared to 2010 (29), whereas hunter-harvest remained relatively stable. No other zones were closed during 2011.

Bighorn Sheep Season Summaries and Recommendations

2011 Bighorn Harvest

Oregon bighorn hunters continued to enjoy high success rates. Nine of 10 Rocky Mountain bighorn sheep controlled tag holders, both special (auction and raffle) tag holders, and two tribal hunters were successful. Eighty-four California bighorn sheep were taken by 82 controlled tag holders and three tribal hunters. Six of the 89 controlled bighorn tags (7 %) were issued to non-resident hunters.

2012 Bighorn Tag Recommendations

The Department is proposing 97 Bighorn Sheep tags (87 California, 10 Rocky Mountain) in 40 hunts (33 California, 7 Rocky Mountain) for 2012 (Table 16). This is an increase of four tags from 93 in 2011. Six tags (one Rocky Mountain, five California) are proposed for non-resident hunters (6 percent).

In addition to Department proposals, as in recent years, it is anticipated that two bighorn sheep tags will be issued to tribal hunters from the Confederated Tribes of Warm Springs (CTWSRO) (one in the John Day River Canyon and one in the Deschutes River Canyon) and the Confederated Tribes of the Umatilla Indian Reservation (CTUIR) will issue three tags (one in the Burnt River area and two in the Lookout Mountain hunt area).

2013 Bighorn Season Recommendations

The Department will propose standard calendar shifts for most bighorn sheep hunts (Table 16). One new hunt period will be added for the East Whitehorse hunt area.

Rocky Mountain Goat Season Summaries and Recommendations

Management Activity

During summer 2010 the Department captured 45 mountain goats from the Elkhorn Mountains in Baker County and released them near White Water Creek on lands of the CTWSRO near Mount Jefferson. Animals survived well and most are staying in the vicinity of Mount Jefferson. The Department is planning to augment this translocation with an additional release of about 20 animals in late July. Animals will again be captured in the Elkhorn Mountains and released in upper Whitewater Creek.

2011 Rocky Mountain Goat Seasons

In 2011, the Commission authorized 11 Rocky Mountain goat tags in eight controlled hunts and one special raffle tag. Rocky Mountain goat hunters continue to have high success rates and the required field orientation provided by biologists continues to be useful to help hunters minimize harvest of female goats.

Tribal hunters from CTUIR harvested an additional two mountain goat in 2011.

2012 Rocky Mountain Goat Tag Recommendations

The Department is proposing 11 Rocky Mountain goat tags in eight hunts (Table 17). In addition to Department proposals, the Department expects tribal hunting from the CTUIR during 2012.

2013 Rocky Mountain Goat Season Recommendations

The Department will propose no changes to Rocky Mountain goat hunts in 2013 except for standard calendar shifts for existing hunts (Table 17).

Pronghorn Antelope Season Summaries and Recommendations

Pronghorn Population Overview

Pronghorn populations are doing well in parts of southeast Oregon (Lake and Harney counties) but continue to struggle in Malheur County. This reflects the variable summer and winter conditions across the landscape during the last year.

2011 Pronghorn Harvest

Although not all hunts were surveyed, survey data indicate that in general, pronghorn hunters continue to enjoy good success. Average success rates were 77% for rifle buck and either-sex hunts, 55% for rifle doe hunts, 37% for muzzleloader hunts, and 22% for archery hunts. In total, 1,248 bucks and 118 does were harvested in the surveyed hunts.

2012 Pronghorn Antelope Tag Recommendations

The Department is proposing 2,680 tags in 56 hunts for 2012 (Table 18, Table 19), representing an increase of about 1 percent from 2011 tag numbers. The proposal for more tags reflects increases in populations in Lake County.

2013 Pronghorn Antelope Season Recommendations

No changes are proposed to the 2013 controlled Pronghorn seasons except for standard calendar date shifts (Table 19). One hunt area (447 Northside Unit) is proposed to expand slightly to provide access to additional animals.

Deer Season Summaries and Recommendations

General Winter Conditions

Western Oregon: Winter 2011–2012 was relatively mild in western Oregon until late when a number of storms brought snow, high winds, and significant moisture to the Cascade and Coast ranges. The prevalence of Deer Hair Loss Syndrome remains variable across western Oregon, primarily at elevations below 1,500 feet.

Eastern Oregon: Many areas in eastern Oregon experienced a mild dry winter with animals in good condition this spring. Overwinter survival was good in most areas; unfortunately fawn and calf ratios were low to moderate in many areas going into winter. Mild winter weather contributed to fewer damage complaints, particularly those caused by elk. Similar to western Oregon, winter persisted late into spring.

Overall, 2012 spring surveys found good winter survival in many deer and elk herds. However, the dry fall in 2011 resulted in many herds going into winter with fall fawns and calves in less than ideal condition, the mild winter moderated the impact to some herds.

Deer Season Summaries and Recommendations

The Mule Deer Plan season framework designates the buck deer season will open the Saturday closest to October 1. Many other seasons, including controlled and general seasons are adjusted accordingly to avoid season overlap (Table 8).

Most buck deer hunting in western Oregon is under a “general season” framework which allows participation by any hunter who purchases a tag before the tag sale deadline (Table 10). Exceptions include controlled High Cascade buck hunts (with tags also valid during the western Oregon general deer seasons), controlled buck hunts in the Umpqua drainage, controlled muzzleloader hunts, controlled antlerless or either-sex hunts, and controlled youth hunts.

As specified in the Mule Deer Plan, all firearms hunting for deer in eastern Oregon is conducted under a controlled hunt system with tag numbers based on biological assessments of herd trend, post-season buck ratios, and other considerations such as weather, hunter crowding, and hunter success. Firearm hunts for antlerless deer are primarily used to address damage and for population control.

In 2003, the southwest Oregon population of Columbian white-tailed deer (CWTD) was removed from the Federal Endangered Species List. Biologists continue to monitor the population. CWTD populations have grown at a consistent rate since 1975. Buck ratios have averaged slightly over 20 bucks per 100 does and recruitment has averaged about 30 fawns per 100 does.

2011 General and Controlled Deer Season Harvest

General black-tailed deer hunter participation declined in 2011: western General rifle hunters declined 5% to 69,656 and the number of western Oregon bow hunters with general tags

increased 5% to 19,118. Harvest increased slightly for both for rifle hunters and archers. Not all controlled hunts were surveyed for 2011 so number of hunters cannot be accurately estimated. However, data from those 600 series (primarily antlerless/spike) hunts that were surveyed suggest the number of black-tailed deer hunters and harvest decreased slightly in 2011, consistent with the reduction in tags offered.

For eastern Oregon, the number of general deer bow hunters remained stable and number of controlled buck rifle hunters declined 4%. Associated harvest remained stable for bow hunters but increased for rifle hunters.

Proposed 2012 Controlled Deer Tags

The Department is proposing no changes to controlled archery and an increase of 51 muzzleloader tags for deer in 2012. The Department is proposing a slight decline (<1%) in the number of controlled buck deer tags (57,795) for 2012 (Table 20). This decline is mainly a function of changes in correction factors for individual hunts. The Department is proposing to reduce controlled rifle antlerless deer tags by six percent to 8,917 for 2012 (Table 21). This reduction is in response to declining black-tailed deer populations in northwest Oregon. Proposed tag numbers for youth hunts will also decrease 3% to 1,233.

Proposed 2012 Deer Seasons

At this time the Department is proposing to maintain existing general season structure with standard calendar adjustment to season dates for 2012 (Table 8). The archery bag limit is a legal buck except in units identified by the Commission each year (see Figure 1 on page 8).

For 2013, the following changes are proposed to controlled deer hunts (Tables 20 and 21). Overall, Department proposals would delete three hunts and add two new hunts. Proposed changes include:

- Delete the S Paulina muzzleloader and bow hunts and replace them with unit-wide hunts.
- Delete 621C Simpson Creek.

Elk Season Summaries and Recommendations

There is a mixture of season structures used for elk hunting in Oregon. Hunters can participate in general season Roosevelt elk rifle hunting in the Cascades and most of the Coast Range. Limited areas are available for general season Rocky Mountain elk hunting during both the first and second seasons in eastern Oregon. Most archery hunting for elk is general season.

Controlled seasons are used for many eastern Oregon bull and either sex hunts and some western Oregon bull hunts. Controlled bull hunting is practiced for several reasons, including achieving the bull ratio MO in areas where vulnerability of bulls has led to over-harvest under general seasons in the past; or where hunter numbers are limited to improve hunting quality. All firearms antlerless elk hunting opportunity is by controlled hunts. Antlerless hunts are used primarily to address damage and reduce populations which are over MO.

2010 Elk Harvest (Note, since 2004 harvest surveys are not conducted for all hunts (Table 22).

Concerns were initially expressed regarding 46 extended season youth elk hunts which were new in 2010. These 5-month long youth hunts for antlerless elk were designed to provide maximum opportunities to hunt amongst all the other demands competing for their time. In total, 693 antlerless elk tags were authorized for these hunts in 2011 (678 in 2010).

The primary concerns were with overlap of the youth rifle hunts with General and Controlled bow hunts and hunting during August when calves are likely still at heel. As a result of these concerns, a

special telephone survey was conducted again this year for these hunts. The hunts continue to be very well received. Highlights of the results are as follows:

- 96% of the tags authorized were purchased (98% in 2010)
- 91% of the youth purchasing the tag reported that they hunted (93% in 2010)
- 88% (86% in 2010) of the hunters reported making at least one special trip to hunt with this tag, 68% (66% in 2010) of the hunters reported another deer or elk season was open when they were hunting
- 4,396 youth days afield were relatively evenly distributed over the five month season
- 153 – 222 youth cow elk hunters in the field monthly
- 279 elk harvested by 613 hunters for 46% overall success rate (0% - 100% by hunt). Of those hunters that hunted and reported harvesting an elk, 23% (24% in 2010) reported harvesting their elk during August (estimated 63 elk)
- 97% of tag holders that hunted enjoyed the hunting experience (same as 2010)
- 95% (94% in 2010) of unsuccessful hunters and 98% (same as 2010) of successful hunters indicated they will try to hunt elk again

Proposed 2012 Controlled Elk Tags

Most archery elk hunting is conducted under general seasons. For the 16 controlled bow hunts for elk, the Department is proposing 5,075 tags for 2012 (Table 23). Proposed controlled muzzleloader elk tags are down 2% (42 tags) to 2,452 for 2012. Proposed controlled elk rifle tags for 2012 are up slightly to 48,507 tags. The Department is proposing a 2% decrease in youth elk tags to 1,052 for 2012.

Proposed 2013 Elk Seasons

At this time the Department is proposing to maintain existing general season structure with standard calendar adjustment to most season dates for 2013 (Table 8). The archery bag limit is a legal bull except in units identified by the Commission each year (see Figure 1 on page 5).

For 2013, the following changes are proposed to controlled elk hunts (Table 23). Overall, Department proposals would delete 16 hunts and create 12 new controlled elk hunts. Proposed changes include:

- Eleven small cow hunts in the Alsea and E Stott Mtn. units are being deleted and replaced with three hunts with a larger hunt area.
- Delete the SW Santiam #3 and Norton Creek antlerless hunts.
- Delete the unit-wide Ochoco antlerless hunt and replace it with two private lands hunts to move elk back onto forest lands, and add a second controlled bow hunt for bulls in the Ochoco Unit.
- Add three new spike only controlled bow hunts in Mt. Emily, Walla Walla, and Wenaha Units, and make all controlled elk hunts in these unit only opportunity hunts.
- Add a second muzzleloader cow hunt in the Elkhorn Mountains.
- Add a third youth cow hunt in the Wilson Unit.

Premier Unit Bull Elk hunts: MT Emily, Walla Walla, and Wenaha

The Department is aware of concerns regarding conflicts of spike hunters with hunters who have a difficult to draw "One Bull" tag in the Mt. Emily, Walla Walla, and Wenaha WMU's. Wildlife Division staff recently met with NE Region Managers and Biologists, and Oregon State Police Troopers specifically to discuss both rifle and archery elk seasons in these three units.

During the meeting it became apparent all of the problems, conflicts, and enforcement issues mentioned were associated with the "spike only" hunters during archery season; there were no ready examples of problems or conflicts with "Spike Only hunters" during the rifle season. While the Department has not received a formal estimate of non-compliance from OSP regarding their elk hunter contacts in these units, both the troopers that work the area and Department staff consider problems during the archery season very common. As one example a hunter took 4 big bulls in three years using general season tags.

Concepts developed at the meeting include some that would restrict archery "spike only" hunters. Virtually all of the problems have involved hunters with general archery season tags valid for "spike only" in these premier units illegally taking branch antlered bulls.

To increase the likelihood of increasing "One Bull" tags in the future it is important to reduce the "loopholes" being used by some hunters to illegally take branch bulls.

Proposals being considered for 2013 will be provided to the Commission June 2012; adoption of 2013 regulations will occur in October, 2012. Current concepts include:

1. Changing spike only tags for these three units to controlled hunts specific to the WMU.
 - a. Reduces opportunity for general season hunters to take a branch bull and claim they shot it in a different WMU
 - b. Creates capability of reducing spike tags potentially resulting in more "One Bull" tags in the future
 - c. Allows some spike hunting for individuals who traditionally hunt the WMU
2. Make these controlled hunts the hunters only archery elk opportunity for the year
 - a. Eliminates a "Spike Only" hunter from taking a branch bull and claiming they shot it in a different WMU, their tag is only good for a spike in the WMU it was issued for.
 - b. Would reduce competition for these tags to those hunters dedicated to hunting these units.
3. Require controlled elk tag to deer hunt during the archery season (same system used in Sled Springs, Chesnimnus, and Ochoco).
 - a. Eliminates the option of a hunter with general deer and elk archery tags legally "hunting deer" with a general season archery elk tag in their pocket
 - b. Eliminates opportunity for a person legally archery deer hunting to shoot an elk for a tag holder

For 2012, the Department is proposing reductions in spike hunting opportunity for rifle hunters and increasing branch bull tags slightly in these three WMUs.
